

Friends of Karen helped with hospital travel, food assistance, and our cell phone bill. A couple of times when Alexis was in the Pediatric ICU, and at the end of his life, they paid our rent, so we didn't have to worry about paying the bills. They called or came to my home to check on Alexis and all of us. They always thought about everything. The kids had school supplies for their first day of the new school year and got to open Christmas and birthday gifts. A few months after Alexis died people went away, went back to their lives. Sometimes you feel alone, but it is comforting knowing Friends of Karen is still present in our lives."

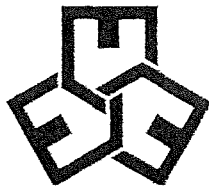

Dear Ms. Ropicki

On behalf of Building Neighborhoods Together (BNT), we are writing to request a charitable donation in the amount of \$7,500 from Fairfield County Bank. The requested donation will assist BNT in growing its Empowerment Resource Academy program to meet the significant increase in demand for its financial literacy, rental assistance and crisis management education and counseling services, the need of which has grown two-fold since the start of the COVID-19 pandemic.

A report from Stout, Risius, Ross estimates that between 77,000 and 161,000 tenants in Connecticut are at risk of eviction and owe between \$149-274 million in back rent. In BNT's own affordable housing portfolio, almost half of our 425 tenants are behind in their rent due to COVID. In January 2021, Pulse Data reported that 48% of Latinx tenants and 23% of African American tenants in Connecticut have little or no confidence that they would be able to pay their rent the following month, compared to only 12% of white tenants. As for homeowners, Black Knight determined that over 9% of Connecticut's 571,513 mortgages were delinquent at the end of June 2020, compared to 3.8% in February 2020. It is believed that a significant number of low to moderate income Fairfield County residents are and will continue to be at risk of eviction and foreclosure and will need BNT's services more than ever before. This increased level of need is expected to continue through 2022 due to the anticipated long-term effects of COVID on the communities ERA serves.

Founded in 1986, Building Neighborhoods Together (BNT) works to end housing insecurity, income inequality and homelessness by creating safe, affordable housing, and providing comprehensive financial and housing counseling services. BNT is the most active nonprofit affordable housing provider in Fairfield County and among the most active statewide. BNT has built, owns, and manages over 225 units of affordable housing, over half which was built in the past 7 years, representing an investment of about \$30 million. BNT's Empowerment Resource Academy (ERA) is the most active US Department of Housing and Urban Development (HUD) approved and Connecticut Housing Finance Authority (CHFA) certified housing counseling agency in Fairfield County, and among the most active statewide. We have grown significantly over the past few years, and in 2020 served approximately 3,000 individuals statewide.

ERA's classes and counseling services seek to improve the economic stability of low to moderate-income households. Its focus is to educate families to achieve housing self-sufficiency, build

expansion also validates the increased funding need for our services, commensurate with the increased need for its services.

To meet ERA's projected growth, BNT will need to grow its operations, adopt more automated processes and procedures to gain further efficiencies, and increase the level of marketing and outreach to its community partners, and ultimately those individuals in need of our help. Our funding request will enable Building Neighborhoods Together to meet these growth requirements and to continue as the premier housing counseling service agency in Connecticut.
